



## RULES FOR THE USE OF THE SWIMMING POOL

These regulations are established for the normal conduct of the customers' activities for the protection of their health, for their comfort and for the respect of order and cleanliness in the establishment.

Knowledge, understanding and observance of these rules are compulsory for all persons using the swimming pool. It applies to all tourists, who accept it by the very fact of their accommodation in the guesthouse and must limit themselves without limits or reservations.

- Pension Coralia informs that the safety of persons accessing the swimming pool is not ensured by professional persons, the pool is installed strictly for the leisure and use of adults, who may use it at their own risk.

- Pension Coralia does not provide access to the pool by qualified persons in this field, does not employ a lifeguard and disclaims any liability arising from any damage to persons using it.

- Pension Coralia does not assume responsibility for non-compliance with these Rules by guests and will not grant moral or material compensation of any kind/financial in case of accidents or loss of personal property.

- Pension Coralia reserves the right to refuse access to persons who have behaved inappropriately, guests under the influence of alcohol, medication or drugs.

- Parents, guardians and accompanying persons who are responsible for the care of children or other persons (persons of unsound mind, etc.) are responsible for ensuring that the children and persons in their care or under their supervision comply with the rules throughout their stay.

- Children may only enter the pool accompanied and supervised by an adult (responsible for them)! It is strictly forbidden for minors to enter the pools unaccompanied or unsupervised.

- The use of the pool requires specific equipment.



Entry to the pool is in swimwear only; no casual attire or underwear is allowed.

- Before using the pool, guests are required to pass the hygiene filter. Access to the pool will be after a shower to remove acidic substances from the body.
- For people with long hair, it is recommended to tie it back in a ponytail or use a swimming cap.
- Exit from the pool only on a ladder to avoid slipping or injury.
- A special sunbathing area should be used. Sun loungers and umbrellas cannot be moved.
- The pool area must be kept clean and hygienic.
- Damage to pool property will result in the responsible persons being charged. Refusal to pay for damage of any kind will result in the consequences laid down by the legal regulations in force.
- Any complaint or claim from customers will be sent to the management by email or directly to the administration.
- The area is partially monitored by video in legally permitted areas. These recordings will only be used in cases of non-compliance.
- We are not responsible for personal belongings, valuables left on the sun loungers as well as forgotten or lost items.
- In case of extreme weather conditions that may endanger the health of guests, the management may take the decision to close the pool indefinitely,

## IT IS FORBIDDEN:

- Jumping into the water, from the side of the pool, bar or stairs.
- Running around the pool.
- Placing objects on the pathways (towels, bags, personal items).
- Pushing people on the edge of the pool.
- Throwing objects into the pool.
- Access with drinks from outside the establishment.
- Access with pets.
- Access with weapons or substances prohibited by law.
- Smoking in the pool and sun lounge area.
- Access to the pool area with chewing gum.
- Nudity or any indecent behaviour.
- Photographing and filming other people or violating their rights. You are solely responsible for violating the rights of others in such cases.
- Consumption of alcoholic beverages and food of any kind in the pool
- Urinating in the pool water is strictly prohibited. The person responsible for this will be indicated and will be charged with changing the water in the pool and compensating the other customers present at the pool.
- Access with personal sound systems (wireless speakers) that would disturb other pool guests.
- It is forbidden to use obscene, foul language, indecent, violent gestures, as well as behaviour that affects the comfort and physical integrity of the guests and the pool staff.
- Persons with one or more of the listed conditions are not allowed in the pool: known allergies to chlorine and its compounds, allergic diseases other than chlorine, conjunctivitis or chronic keratitis, chronic upper respiratory diseases, chronic bronchopneumopathies including bronchial asthma, dermatoses or other skin diseases, anaemia, epilepsy, mental disorders, neurological disorders, evolving infectious-contagious diseases (including carrier state until sterilization), tuberculosis, salmonella, vibrio, hepatitis A, open wounds.

Pension Coralia is exonerated from liability for possible deaths, injuries to the body, accidents caused by the guests' fault (drowning, slipping, etc.) and any kind of damage (damage, damage) caused by theft, destruction, damage to property.

In case of violation of the obligations assumed at the time of access to the swimming pool, obligations contained in a general, unlimited way in these Rules, the administration has the exclusive and irrevocable right, at its own discretion, to cancel the access of the person/persons to the swimming pool.

Any disputes or disagreements will be settled amicably between the parties and in the event of failure to resolve them, disputes will be settled in court.
